Acceptance of payment after this period is not to be construed as a change in terms. Liquid reserves the right to charge interest at the highest legal rate on all past due amounts. Buyer agrees to pay reasonable attorneys fees and all other costs and expenses, including, but not limited to, applicable restocking, storage, insurance and freight incurred by Liquid in the collection of any obligation of Buyer pursuant hereto. In the event of a default, Liquid reserves the right to collect all delinquent interest, including unbilled interest. Unbilled interest shall not be construed as a waiver of Liquid's rights to collect such interest in the event of default. Any notice of claim of non-conforming, defective, or otherwise unacceptable goods must be presented to Liquid within 10 days of receipt of goods. Buyer also agrees to notify Liquid of any disputed invoices within 10 days of receipt. Failure to notify Liquid of any dispute with respect to billing or of defective goods shall constitute a complete waiver of any and all such disputes. It is understood that Liquid has the right to revoke credit privileges at any time without prior notice. In the event Liquid determines that information contained on this credit application is false or misleading, Liquid may, without further notice, cancel any pending orders, or any deliveries in progress. Any false or misleading information by Buyer shall be construed as a material default, and any invoices outstanding shall be immediately due and payable in full. Buyer shall not transfer or assign its rights to purchase goods from Liquid without prior written consent of Liquid. The undersigned agrees to notify Liquid immediately upon any changes in the information provided on this application. The undersigned agrees that Liquid is hereby granted and shall retain a security interest in and to any goods and materials delivered to Buyer by Liquid and proceeds thereof until all indebtedness is paid in full. Until the debt is paid in full, Liquid will have all rights of a secured party as provided by the Arizona Commercial Code, including the right to collect a deficiency. This credit application constitutes an agreement, and has been entered into and is to be performed in Yuma County, Arizona Buyer consents to be subject to the personal jurisdiction of the courts located in Yuma County, Arizona for any dispute arising hereunder. In the event of insolvency, a substantial change in financial condition, reassignment of debt, or should the account become delinquent, any and all invoices, including future dated invoices shall become due and payable immediately.
